CHRISTIANS AGAINST POVERTY

Ashby CAP Debt Centre has entered hundreds of homes in the last 14 years and seen many families go debt-free. As a team working with the head office in Bradford, we have supported those families with their budgets to pay off or write off over a million pounds of debt through insolvency, which is utterly amazing.

During 2024, we said goodbye to Katie Johnson, our CAP Services director, who has gone on to a Role with CAP head office, helping churches with their mission, evangelism and discipleship. WE are so grateful to God for how he has blessed our church, Debt Help centre and clients through Katie's time with us.

In addition:

- We have continued our long-term support of families on debt management plans or going through our resolution teams.
- Mike, our Debt Coach, has gone into home after home, working with those families with very complicated needs.
- Fresh start support remained in place for those struggling with addiction
- The weekly drop-in at Pathways Cafe continues with a help desk there.
- We also helped families with emergency needs through our connection with ACTS 435

The cost of running this vital service is fully funded by generous donations from regular givers, grants and charitable groups like yourselves.

PATHWAYS CAFÉ

We have had another wonderful year at Pathways, and we have been presented with two awards: one from the Mayor of Ashby and another from the Chief Commander of Leicestershire Police.

30-50 members are coming to Pathways each Thursday morning. Some have not seen anyone to talk to for a week, and this is their weekly social event. They have a hot drink, a snack, and a nice natter with their friends.



It is a warm and very welcoming environment. We offer a craft table, which does various crafty things depending on what is coming up in the year, for example before Christmas this was the craft theme for four weeks. Planting bulbs for Mother's Day, and making Easter cards and Easter gardens. Some others bring their own knitting and crochet to do.

We would like to give big thanks to HIB (they are a company that supports local communities' initiatives), who come monthly, this is an immense help to the volunteers, and they spend some time chatting with the members. They gave us a few items that we needed, for example, tea towels, plates, an apron with "pathways" on, and tables.

We still have local and national agencies that come in, they are CAP, CAB, and a local link coordinator to name just a few. Times are getting harder for people so Pathways is now, and will be in the future, a great comfort to many.

So, if you know anyone needing help or guidance, direct them to Pathways.

Also, I am pleased to tell you that a member of Pathways has made a commitment to the Lord. This was fantastic to hear.

Sadly, we said goodbye to our dear friend and volunteer Pat Goldsmith. She was a huge part of Pathways and will be missed by us all.

THE GARDEN ROOM

The Garden Room is a community gardening project, rooted in the life of Holy Trinity Ashby. We grow flowers and food to share with our community.

Since the seeds of the project were planted during the pandemic, the project has continued to develop and grow, putting down deeper roots in our life together and seeing more shoots sent out into the local community.

In 2024, we continued to grow flowers and food across two sites: a small secret garden near the church and a larger plot of raised beds down at the allotments, where we have a partnership with Ashby Allotment Association. A few of us also look after seedlings and young plants on our windowsills at home.

We meet up for an hour a couple of times a week, on Monday and Wednesday afternoons, from March to October. This usually involves around 45 minutes of gentle gardening, followed by a cup of tea - sometimes in the company of one of our local neighbourhood robins.

We run monthly events on Saturday mornings at the back of church, where alongside a pop-up Garden Room Cafe, we host various horticultural events.

In 2024, these included another one of our popular community seed swaps, a couple of bring and buy plant sales - and several fun with flowers events, where people can choose and arrange a jam jar of flowers to take home, or pass on to a friend, family member or neighbour.

We also took part in the Ashby Open Gardens event in the summer, as part of the Ashby Allotments group, which used the community plot we grow on as their base for the weekend. On the Saturday morning, as well as giving away lots of jars of flowers, we were able to serve plenty of cups of tea, coffee and cake.

Over time, we have gradually evolved what we do, to devote more space to growing flowers and over the last twelve months, we have given away hundreds of jam jars filled with flowers across Ashby and the surrounding villages.

We love growing flowers together, but as we say: "It's about the flowers. It's also *not* about the flowers".

What the growing and giving away of flowers continues to do, is give us opportunities to connect with people in our community.

We have been blown away by the number of conversations we have been able to have over the last year, with people who don't have a connection with a local church. Opportunities to listen to people, hear their stories, drink tea and garden together - and in some cases, to become part of their lives.

One of the highlights of last year, was cutting a car full of flowers and taking them with a big box of jam jars to a local care home, which is home to the mother of one of our volunteers. We spent a lovely afternoon with the residents, working alongside them to make up jam jar posies for them to enjoy and share with those who were unable to leave their rooms.

We remain a small, cheerful band of volunteers and helpers. Alongside folk from Holy Trinity, this includes a couple of people from other churches in Ashby, and one or two who are not part of a local church.

Helping with the Garden Room continues to operate on a very relaxed and informal basis. There is no rota - people simply come when they can, not when they can't. No previous gardening experience is required.

We would love to welcome more people to join us as we continue to grow together in 2025. Please get in touch, if you'd like to find out more about getting involved.

NORTH WEST LEICESTERSHIRE DEANERY SYNOD

Revd. Gillian Pinnington was licensed as Area Dean in 2020, the Assistant Area Dean is Revd. Laura Jackson.

Three representatives to Deanery Synod are elected at the APCM and may stand for two terms of three years, currently, Kathy Hart, Jean M. Harrison and Noreen Mewies are the Holy Trinity Representatives.

Key note speakers at each Synod in 2024:

March 2024

Cost of Living Crisis

Rev Gill welcomed Phil Antill from Hope67, a community money advice service with Christian values, who are based in Coalville. Hope67 are partnered with Coalville Foodbank.

Phil talked about the type of help they offer, the number of households they have helped and how people get to hear about their services, this is usually via foodbanks and the council.

Phil concluded his talk by asking us to pray for Hope67. Needs are increasing and support is decreasing. He asked we pray that the local authority will use money wisely, to pray for the team, most of which are volunteers, and to pray that people will find them.

Questions were invited, Phil confirmed that his leaflets are distributed to foodbanks.

Christ Church – Rev Gill talked about the Camerados group who meet in the church hall every Tuesday morning where people come along with their crafts and have a cup of tea and enjoy the companionship and warm space. At the same time, an “essentials table” is set up for the community to purchase household items such as cleaning products, personal hygiene items – shower gel, toothpaste, soap etc., toilet rolls and laundry products. These can be bought for much less than in the supermarkets and is funded by donations from the congregation.

A new “Caring Café” has started on a Tuesday afternoon, and this offers a warm space, in a quiet environment for people to come along and have tea and cake and a listening ear.

Foodbank – Jean M. Harrison talked about her work with the Ashby Foodbank. At that time, they had helped 2,153 people and this was rising. The Ashby Foodbank is part of the Trussell Trust, and they work closely with Coalville Foodbank.

Rev Gill invited people to talk about what their churches are doing for their communities to help with the Cost-of-Living crisis; -

- Whitwick have food boxes in church for donations and a “sharing shed”.
- St Helens offer warm spaces at the Heritage Centre.
- Broom Leys have bags which their congregation fill and they get taken to foodbanks.

People were reminded that Morrisons have bags which are made up with food items to purchase and this is a simple way to help others.

- If Hope67 know what our churches are doing, they can signpost people there.
- Thringstone have a warm space on a Thursday. They also have a church allotment, and all produce from this is given to the community for free. They also collect toys at Christmas time which are donated to the Marlene Reid centre.
- The Woodfield Team have coffee and chat sessions and a lunch once a month.

Rev Gill was impressed with the wonderful things that churches are doing and we had a moment of quiet to think and pray about what we had heard.

June 2024

Outdoor Worship - OWL, Forest Church and Muddy Church

Rev Gill welcomed Anne Scott our speaker from OWL. OWL supports and encourages outdoor worshipping communities and inspires new ones. They held their first conference in October 2023 and 50+ people attended. The 2024 conference was held in September at Launde Abbey.

Some examples were given about how churches can get involved in outdoor worship.

Outside Blessings, Communion and Services of Praise all held around a campfire, Pilgrimage and Prayer Walks, Meditation, Biodiversity, and messy, muddy and forest church.

Anne gave some examples of what was happening, in Long Whatton there had been a walk around the village which ended with reflection and prayer. At Bottesford there is Windmill Church. Souls in the Wild at Swithland Woods starts with an inspirational quote and a walk, at the end of which they share their thoughts and enjoy food together.

October 2024

Diocesan Finance – Simon Wilson, Diocesan Finance Director

Simon began by saying that the Diocese currently has a deficit of 2.2 million pounds and that steps are being taken to address this involving cutting roles both clergy and support staff which will lead to a reduced service from the Diocese.

He said that an aim to increase income is the best way to solve the deficit but that Parish contributions over the past eleven years had reduced considerably.

Simon reiterated that clergy posts have been cut and that vacant posts are not being replaced. Also there had been staff redundancies in St Martins House and the book shop has now closed. Parish contributions should be viewed as a gift from parishes to the Diocese, rather than a subscription and Parishes should be encouraged to properly assess these in a fair-minded manner.

Simon also said that the way the Diocese operates in the future will be affected by the formation of Minster Communities.

Simon took a number of questions from the meeting including:

‘Who controls the expenditure?’ – there are various committees and a board of trustees, and ultimately the Bishop of Leicester is in control from a mission perspective.

‘Other sources of income?’ – from the National Church but this has to be applied for and spent on specifically identified projects.

There are also endowments in the Diocese.

A point was made about the well-being of clergy especially in the light of job uncertainty and living in ‘temporary’ rented accommodation which made them feel disposable.

It was felt that creativity was missing from the Diocese for forming solutions to the financial problem.

Simon said it was vital that the Diocese needs to get the bidding right when applying to the National Church.

‘Is the Diocese genuinely expecting more income?’ – Simon said that parish contributions may or may not increase – all the Diocese can do is ask!

He pointed out that the Diocese could well be bankrupt in five years especially as church attendance is down by 45% currently.

A point was made that as the National Church is sitting on 12 billion pounds, that surely some of this could be distributed to allow more priests and split administration into workable areas.

Simon said that if anyone had further questions to contact him via email or ask Avril to contact him.

Gill thanked Simon for coming to the meeting.

December 2024

This was a short business meeting, an opportunity to view the refurbishment of St John Donisthorpe and its transformation into a beautiful community space and hear a little of how this was achieved.

The meeting concluded with Advent Worship led by Red Steve O'Rourke and tea, coffee and mince pies.

Laity Meetings

Four meetings were held during 2024, mostly well attended, they offered the opportunity to listen to each other, to hear and share good news stories and raise concerns and worries all kept confidential. More meetings will be held in 2025.

Newsletter

Three newsletters were produced in 2024, with the next edition planned for March 2025, it will include good news, what's happening in our churches, and things to pray about etc.

Church reps are asked to send their items to Avril (Deanery Secretary) who would collate the items and produce the newsletter.

Prayer Walks 2024

Over the summer Gill, Noreen, Jean and Geoff took part in several Prayer Walks in the Deanery. Each walk was very different, but all started with worship and short talk before setting off, all offered the same opportunity to talk to people passed on the walk, the time to listen to each other, to pray together and enjoy wonderful hospitality.

One of the walks was from St Helen's along Market Street to Holy Trinity, from there to Ashby Methodist Church to join Ashby Youth for Christ for their monthly Team Prayer Time, this was enjoyed by everyone, before going to the Courtyard Café for coffee.

More walks will take place in 2025.

Deanery Event 2025

It has been proposed that a Deanery event be held on Saturday 21st June 2025 starting with breakfast at 9.30am, the day will include bible study, worship and workshops, the venue has yet to be arranged and information will be sent out as soon as it is available.

Minster Community

During the first three months of 2025 the Parish Transition and Ministry team will be leading vocational conversations with existing ministers, both lay and ordained, to talk about how their ministry might look in the future Minster Community (A2A).

There will also be an open session for those not yet involved in ministry and for those interested to find out how they may be able to serve their local church and community as part of a Minster Community.

Parish Contributions for 2025 would, on paper, appear to be sufficient to support four stipendiary posts.

There will then be some key process sessions to help us get from the Working Groups to a point where a proposal can be drafted:

1. A Coordinating Group session on 23rd January 2025

This is a session for the Coordinating Group to study the collated summary of the Working Group reports, and look at the opportunities and challenges arising from the reports. This will then be shared with the parishes.

2. A session for Parish Reps – February 4th 2025 at St Helen's Heritage Centre at 7.00pm

This is a session for parishes to send reps to discuss the findings and recommendations of the Working Groups. The aim will be for parishes to share their feedback on the reports, to state anything they think is missing and to begin to articulate a missional direction for the Minster Community.

3. A service of prayer and reflection.

The aim is to gather all of the work done so far before God – to lament the hard stuff, to thank God for the opportunities, and pray for the proposal-writing stage.

The next step is for the Coordinating Group to begin to draft a Minster Community proposal with support provided by the group facilitators, with the aim to get a first draft of the proposal ready by early 2025.

Following this the proposal will go out to PCCs and the Joint Archdeaconry Mission Committee (JAMC) so that a final version could be worked on.

The hope being that the Minster Community will have approval to move into the next phase towards the end of the summer.

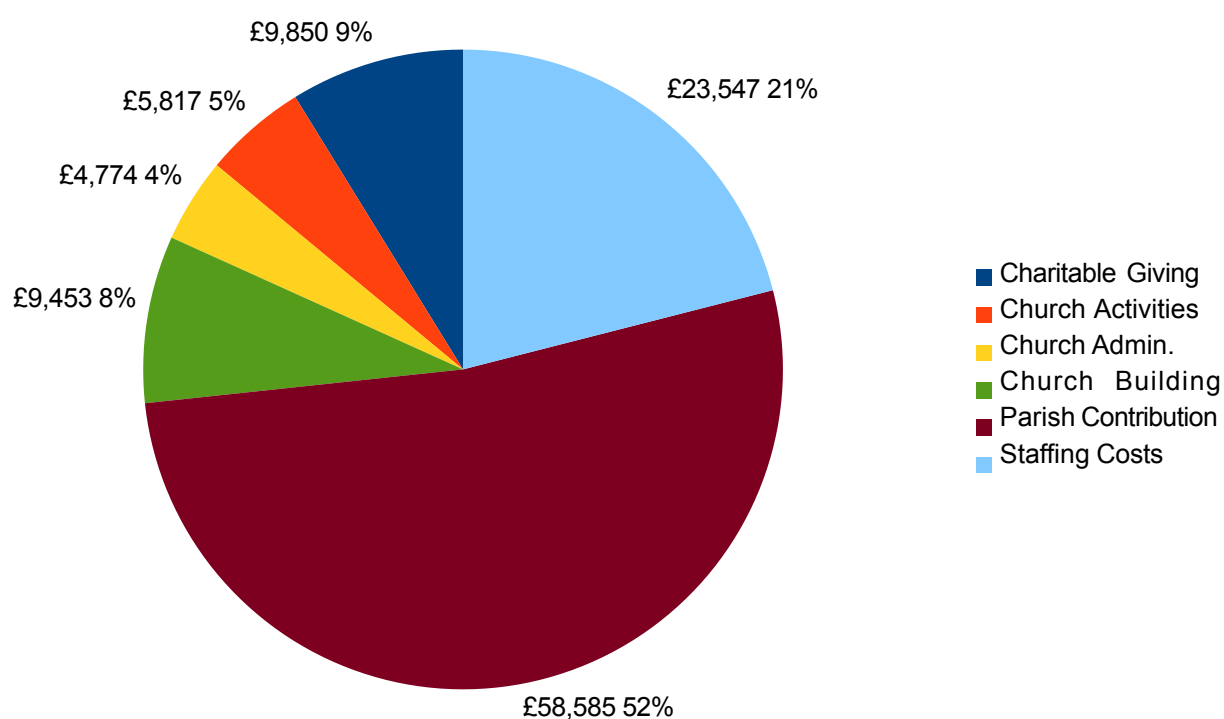

Notes to the Accounts

General Notes

1. The financial statements of the PCC have been prepared in accordance with the Church Accounting Regulations 2006 using the Receipts and Payments basis.
2. The activities of the Church Hall, CAP Ashby and of Ashby Foodbank have been aggregated with the PCC accounts.
3. Fixed Assets, consecrated and benefice property are not included in the accounts in accordance with section s.96(2)(a) of the Charities Act 1993.
4. The Church Hall and associated land are not included in the accounts as assets since ownership is unclear and there is no available valuation at the time of preparation of this report.
5. 2023 figures are provided only for comparison by the PCC with the current year.

Funds

- **Restricted Funds** represent income from trusts or endowments, donations or grants received, or money raised for a specific purpose. Consequently the funds may only be used for the purpose specified by the donor or when raised.
- **Unrestricted Funds** i.e. the General fund, is used for ordinary PCC income and expenditure.
- **Designated Funds** are sums set aside out of the General fund for specific designated purposes. They can be transferred back to unrestricted funds at any time if the PCC so decides.
- **Endowment Funds** are funds, the capital of which must be maintained. Only income arising from investment of the endowment may be used. No endowment funds existed at 31st December 2024.

Notes.

The money held in the Bank across all accounts totals £213,649 at 31/12/2024. This agrees with the total across all in funds on page 2. A correction of £50 write-down has been entered in table 12 under 'Church Admin expenses' to account for a long standing difference arising when the account package 'Expense-Plus' was introduced.

Reserves Policy: It has been agreed by the Church PCC to maintain a reserve of roughly 10% of the General fund income. This equates to £10,000 for 2024 and currently stands at £10,000. The reserve fund is intended only for emergency spending i.e. urgent building repairs or cash flow problems.

Independent Examiner's Report

Report to the Parochial Church Council (PCC) of Holy Trinity Church, Ashby de la Zouch, on the accounts for the year ended 31" December 2024.

Respective responsibilities of Trustees and Examiner

The PCC is responsible for the preparation of the accounts and it considers that an audit is not required for this year under section 744 of the Charities Act 2011 {the Charities Act} and that an independent examination is needed.

It is my responsibility:
